DEPARTURES

All departure dates and rates are guaranteed.

DEPOSIT

A deposit of US\$500 per person must be received within 7 days of reservation. Deposit is refundable up to 60 days before departure, less a US\$200 service fee per person.

FULL PAYMENT

Full payment must be received by Stay and Visit Inc. office no later than 60 days before departure. Any bookings without full payment by this time are subject to cancellation without notice and your deposit will be forfeited.

METHOD OF PAYMENT

Checks should be made to Stay and Visit inc. All major credit cards are accepted through Paypal with a 5% supplement.

IF YOU MUST CANCEL

If you cancel your tour or hotel more than 60 days before departure, your payments are refundable less a US\$200 service fee per person. If you cancel your tour or hotel within 60 days of departure your payment is non refundable.

INDIVIDUAL TRAVELERS

An additional fee will be charged for single guests occupying a double room. Please note that Europe's accommodations are typically smaller.

GRATUITIES

It is customary to reward good service. Especially for tour escorts, waiters, guides, drivers and porters. Their jobs are seasonal and they depend on gratuities. Please extend these gratuities on the last day of the tour.

NOT INCLUDED

Airfares are not included and are your responsibility.
 Tips are not included.

Optional tours as described, admission fees/entrance tickets to museums, galleries, mini-cruises, funicular, bus tickets, subways, trains, water taxi, boats, taxi, etc. are not included.

Please note: Guests are permitted one bag per person.

As of 9/1/2014 the City of Rome has introduced and will collect a new "Tourist Tax" of 6 Euros per night per person (12 and older).

This tax is not included in our rates and must be paid at the hotel. The "Grand Hotel Olympic" will collect the tax in the name of each traveler.

As of 9/1/2014 the Maremma area has introduced and will collect a new "Tourist Tax" of 1 Euro per night per person (12 and older). This tax is not included in our rates and must be paid at the hotel. The "Grand Hotel Corte Dei Butteri" will collect the tax in the



name of each traveler.

As of 9/1/2012 the City of Ischia has introduced and will collect a new "Tourist Tax" of 3 Euros per night per person (12 and older).

This tax is not included in our rates and must be paid at the hotel. The "Grand Hotel Ischia Lido" will collect the tax in the name of each traveler.

As of 9/1/2014 the City of Venice has introduced and will collect a new "Tourist Tax" of 3 Euros per night per person (12 and older).

This tax is not included in our rates and must be paid at the hotel. The Venice Lido Hotel will collect the tax in the name of each traveler.

PRE OR POST TOUR HOTEL ROOMS

As a service we will reserve additional hotel nights for you. These room charges, as well as any private transfers, will be added to your tour cost.

EXPECT RIGOROUS WALKS

Many of the tours' destinations we visit do not permit motorized vehicles in the historic centers. You should expect substantial walking, often on uneven surfaces and up or down steep inclines and stairs. People requiring assistance must have a travel companion who is fully capable and responsible for providing assistance.
